## **SECTION 4** **FIRST AID MEASURES**

**INHALATION:** Remove person from contaminated area to fresh air and assist breathing as needed. Seek medical attention if irritation persists.

**SKIN:** Remove contaminated clothing and shoes. Gently wipe off excess chemical. Wash skin gently and thoroughly with water and non-abrasive soap. Obtain medical attention if irritation persists.

**SECTION 5**  
**FIRE FIGHTING MEASURES**

<b>Suitable Extinguishing Media:</b>	Use carbon dioxide, dry chemical, water fog or foam.
<b>Unsuitable Extinguishing Media:</b>	High volume water jet. Use a water jet only to cool heated containers.
<b>Specific hazards:</b>	Not applicable
<b>Special Fire Fighting Procedures:</b>	Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Keep upwind. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Water can be used to cool unaffected containers but must be contained for later disposal. Avoid pollution of waterways by run-off from the site
<b>Personal protective equipment:</b>	Wear NIOSH/MSHA approved self-contained breathing apparatus and full protective gear.

<b>Personal Precautions:</b>	Avoid contact with skin and eyes. Do not breathe in spray mist or fumes. Ventilate area of spill or leak, especially in contained areas.

<b>Emergency procedures:</b>	Alert firefighting personnel, evacuate unprotected personnel and animals.
<b>Environmental Precautions:</b>	Prevent spilled product from entering sewers, waterways or ground water. This product is classified to be Toxic to aquatic organisms and causes long-term adverse effects in the aquatic environment. Any spillages or uncontrolled discharges into watercourses should be reported immediately to the police and the Department of Water/Environmental Affairs.
<b>Methods &amp; Materials for Containment:</b>	Contain spilled product by diking area with sand or earth.
<b>Methods &amp; Materials for Clean-up:</b>	Cover contained spill with an inert absorbent material such as sand, vermiculite, earth or other appropriate material. Vacuum, scoop, or sweep up material and place the material into a clean, dry, sealable container. Label containers with the contents and dispose of according to local regulations. Do not place spilled material back in original container. Do not re-use spill material. Collect washings and add to the drums already collected. ### **HANDLING**

**Precautions for safe handling:**

Avoid contact with skin and eyes. Ensure adequate ventilation during handling and use. Do not handle broken packages without protective equipment. Immediately clean up spills that occur during handling. Keep containers closed when not in use. In the case of contact with the product refer to First Aid Measures – Section 4.

### **STORAGE**

**Conditions for safe storage:**

Keep out of reach of unauthorised persons, children, and animals. Store in its original, labelled container, tightly closed, in an isolated, dry, cool and well- ventilated area. Avoid excess heat. Not to be stored next to foodstuffs, feed, and water supplies. Avoid cross contamination with other pesticides and fertilisers.

**Waste:** Open dumping or burning of this product is prohibited. Waste resulting from the use of this product cannot be reused or re-processed.
