SECTION 4 FIRST AID MEASURES

INHALATION: This product is not classified as an inhalation toxicant; however, if toxication occurs, remove person from contaminated area to fresh air and assist breathing as needed. Seek medical attention if irritation persists.

SECTION 5
FIRE FIGHTING MEASURES

Suitable Extinguishing Media:	Use carbon dioxide, dry chemical, water fog or foam.
Unsuitable Extinguishing Media:	High volume water jet. Use a water jet only to cool heated containers.
Specific hazards:	None known
Special Fire Fighting Procedures:	Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Keep upwind. Avoid inhaling hazardous vapours and fumes from burning materials. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning material. Water can be used to cool unaffected containers but must be contained for later disposal. Contain fire control agents for later disposal. Avoid pollution of waterways by run-off from the site.
Personal protective equipment:	Wear NIOSH/MSHA approved self-contained breathing apparatus and full protective gear.

ACCIDENTAL RELEASE MEASURES

Personal Precautions:	Avoid contact with eyes. Do not breathe in spray mist or fumes. Ventilate area of spill or leak, especially in contained areas.

Emergency procedures:	Alert emergency personnel, evacuate unprotected personnel and animals.

Methods & Materials for Containment:	Contain spilled product by diking area with sand or earth.

Vacuum, scoop, or sweep up material and place the material into a clean, dry, sealable container. Label containers with the contents and dispose of according to local regulations. Do not place spilled material back in original container. Do not re-use spill material. Collect washings and add to the drums already collected. HANDLING

Precautions for safe handling:

Harmful if swallowed. Avoid contact with skin and eyes. Ensure adequate ventilation during handling and use. Do not handle broken packages without protective equipment. Immediately clean up spills that occur during handling. Keep containers closed when not in use. In the case of contact with the product refer to First Aid Measures – Section 4.

STORAGE

Waste: Open dumping or burning of this product is prohibited. Waste resulting from the use of this product cannot be reused or re-processed.
