**SECTION 4**  
**FIRST AID MEASURES**

**INHALATION:** This product is not classified as an inhalation toxicant, if toxication occurs, remove person from contaminated area to fresh air and assist breathing as needed. Seek medical attention if irritation persists.

**SECTION 5**  
**FIRE FIGHTING MEASURES**

<b>Suitable Extinguishing Media:</b>	Use carbon dioxide, dry chemical, water fog or foam.
<b>Unsuitable Extinguishing Media:</b>	High volume water jet. Use a water jet only to cool heated containers.
<b>Specific hazards:</b>	None Known
<b>Special Fire Fighting Procedures:</b>	Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Keep upwind. Avoid inhaling hazardous vapours and fumes from burning materials. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning material. Water can be used to cool unaffected containers but must be contained for later disposal. Contain fire control agents for later disposal. Avoid pollution of waterways by run-off from the site.

**HANDLING**

**Precautions for safe handling:**
