FIRST AID MEASURES

INHALATION: This product is not deemed to be an inhalation toxicant, however, in cases of inhalation toxication, remove person from contaminated area to fresh air.

SKIN: This product is not deemed to be a skin irritant, however, in cases of skin irritation, remove contaminated clothing and shoes. Gently wipe off excess chemical. Wash skin gently and thoroughly with water and non-abrasive soap. Obtain medical attention if irritation persists.

maximum distance and use unmanned hose holder or monitor nozzles. Keep upwind. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning material. Water can be used to cool unaffected containers but must be contained for later disposal. Contain fire control agents for later disposal.
