SECTION 4
FIRST AID MEASURES

INHALATION: This product is not classified as an inhalation toxicant. However, if toxication occurs, remove person from contaminated area to fresh air and assist breathing as needed. Seek medical attention if irritation persists.

SKIN: This product is not classified as a skin irritant. If skin irritation occurs, remove contaminated clothing and shoes. Gently wipe off excess chemical. Wash skin gently and thoroughly with water and non-abrasive soap. Obtain medical attention if irritation persists.

EYES: This product is not classified as an eye irritant. If eye irritation occurs, flush eyes with clean water for at least 15 – 20 minutes. Lift eyelids to facilitate irrigation. If present, remove contact lenses after 5 minutes and continue rinsing.

Do not give anything by mouth to an unconscious person. If the person is alert, rinse mouth thoroughly with water and give 2 to 3 glasses of water to drink.

SECTION 5

FIRE FIGHTING MEASURES

Suitable Extinguishing Media:	Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide.
Unsuitable Extinguishing Media:	High volume water jet. Use a water jet only to cool heated containers.
Specific hazards:	None known
Special Fire Fighting Procedures:	Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Keep upwind. Avoid inhaling hazardous vapours and fumes from burning materials. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning material. Water can be used to cool unaffected containers but must be contained for later disposal. Contain fire control agents for later disposal. Avoid pollution of waterways by run-off from the site.
Personal protective equipment:	Wear NIOSH/MSHA approved self-contained breathing apparatus and full protective gear.

ACCIDENTAL RELEASE MEASURES

Personal Precautions:	Use personal protective equipment. Ensure adequate ventilation. Avoid dust formation. Avoid contact with skin, eyes and clothing.
Protective equipment:	Refer to Section 8 for personal protective equipment to be worn during containment and clean-up of a spill involving this product.
Emergency procedures:	Alert emergency personnel, evacuate unprotected personnel and animals.
Environmental Precautions:	Prevent spilled product from entering sewers, waterways, or ground water. Any spillages or uncontrolled discharges into watercourses should be reported immediately to the police and the Department of Water/Environmental Affairs.
Methods & Materials for Containment:	Sweep up or vacuum up spillage and collect in suitable container for disposal. Avoid dust formation.
Methods & Materials for Clean-up:	Cover contained spill with an inert absorbent material such as sand, vermiculite, earth or other appropriate material. Vacuum, scoop, or sweep up material and place the material into a clean, dry, sealable container. Label containers with the contents and dispose of according to local regulations. Do not place spilled material back in original container. Do not re-use spill material. Collect washings and add to the drums already collected. Do not flush spilled material or washings into drains or waterways. To decontaminate the spill area, tools and equipment, wash with water and suitable detergent. HANDLING AND STORAGE

HANDLING

Precautions for safe handling: Ensure adequate ventilation during handling and use. Do not handle broken packages without protective equipment. Immediately clean up spills that occur during handling. Keep containers closed when not in use. In the case of contact with the product refer to First Aid Measures – Section 4.

General occupational hygiene: Practice good hygiene when using this material. Wash hands before eating, drinking, chewing gum, smoking, using the toilet or applying cosmetics. Worker should shower at the end of each workday. Launder all clothing before it is re-used.

STORAGE

Conditions for safe storage: Keep containers tightly closed in a dry, cool and well-ventilated place. Keep out of reach of unauthorised persons, children and animals. Store in its original, labelled container, tightly closed, in an isolated, dry, cool and well-ventilated area. Avoid excess heat. Not to be stored next to foodstuffs, feed and water supplies. Avoid cross contamination with other pesticides and fertilisers.

Waste: Open dumping or burning of this product is prohibited. Waste resulting from the use of this product cannot be reused or re-processed. container in the prescribed manner. Destroy the container by perforating and flattening and dispose of through an approved waste dump site, incineration plant or recycling company. Observe all labelled safeguards until container is destroyed.
